Summary of Changes to the Online Chicago Zoning Ordinance

Now the Most Current and Accurate City of Chicago Zoning Map Available

- Zoning District Maps Current Through January 3, 2007
- Over 1200 Zoning Map Changes since March, 2006
- Over 400 Zoning Map Updates since September 13, 2006
- Introducing 27 New Planned Development Areas since September 13, 2006, including the new Downtown Residential-Business Planned Development located on Walton & State and the new Waterway Business Planned Development on Weed & Kingsbury
- **Six New Transportation Districts** established since September 13, 2006 including the Lakefront Transportation District located on Armitage & Lincoln and the new Southside Transportation District on 78th & Exchange
- **Eight New Public Open Space Districts** created since June 28, 2006 including the expansive Southside Public Open Space District at 96th & Van Vlissingen
- **New Features** that allow users to view the last date the zoning district was updated, as well as classification information and definitions
- **A Helpful Staff** available 8:30-5:00 Monday through Friday to field any questions or resolve issues that users may have
